SUBSTANTIAL AMENDMENT TO THE FY 2012-2013 ACTION PLAN FOR COMMUNITY
PLANNING
AND DEVELOPMENT PROGRAMS (ACTION PLAN)**

The City of Fountain Valley Housing and Community Development (HCD) Department, in accordance with U.S. Department of Housing and Urban Development (HUD) regulations, has prepared a Substantial Amendment to the FY 2012-2013 Action Plan for Community Planning and Development Programs (Action Plan). The Substantial Amendment to the FY 2012-2013 Action Plan describes the projects/activities proposed by the City of Fountain Valley utilizing available Community Development Block Grant (CDBG) funds.

For FY 2012-2013, the City of Fountain Valley has prepared a Substantial Amendment to increase funding for the purpose of making Americans with Disabilities Act (ADA) compliant renovations to restrooms at the Fountain Valley Recreation Center.

The following is a summary of the activities that the City of Fountain Valley is proposing for the Substantial Amendment of the FY 2012-2013 CDBG program funding:

PROPOSED PROJECTS/ACTIVITIES

INCREASE THE PUBLIC FACILITIES (ADA IMPROVEMENTS) CDBG BUDGET FROM \$75,000 TO \$275,000 FOR RESTROOM RENOVATIONS AT FOUNTAIN VALLEY RECREATION CENTER.
